- Changes will be presented at the Winter meeting and voting will take place at the Supervision Summit in the Spring
- Current NCACES Bylaw state that we need to have 2 representative on the executive committee at ACA, 1 counselor educator and 1 supervisor
- Supervisor has to be a full time clinician

#### OACES Website

Dr. Lynne Guillot Miller reported that:

- Dr. Jason McGlothlin found a website that will host the OACES website for \$150 for start –up and \$30 per year
- We have the option of using OHACES.ORG or OHACES.NET
- Dr. Daniel Cruikshanks motioned that we move forward with choosing the website and to approve the cost for the site

#### Update on Licensure Examination

According to Dr. Lynne Guillot Miller:

- Starting in January 2006 the licensure exam will be a 2-tier exam
- In order to become a PC individuals will have to take the NCE exam and pass that then they will have to take NCMHCE to get the PCC status
- Dr. Lynne Guillot Miller and Dr. Jason McGlothlin had a meeting with the board last Thursday
- They presented concerns OCA and OACES had regarding the proposed rules changes.
  - These included
    - The ethics of having counselors pay for two exams.
    - The validity of the NCMHC and the match of scope of practice between the exam and practice in Ohio
  - According to Dr. Lynne Guillot Miller the Board felt that:
    - The cost of the two exams will be over two years
    - In Ohio we have the lowest licensing renewal cost
    - 2-tier licensure exam will make us better gatekeepers

Dr. Darcy Granello discussed:

- The board listens but the decisions appears to be made already
- Has concerns about the 2 tests and the cost
- She was informed that the reliability and validity information are confidential

Dr. Paul Granello discussed:

- No statistical data is available
- In Ohio we have a 90% passing rate on the first part of the exam and a 69% passing rate on the second part of the exam
- Nation wide there is a 65% passing rate on the second part of the exam
- No implication of tracking
- Racial bias is a concern
- What is the quality control for the 3000 supervised hours?
- The board role is to protect the public
- Other states do not have as many people taking the exam as Ohio

Dr. Daniel Cruikshanks discussed:

- Individuals that passed the current exam if they do not get their 3000 supervision hours completed by December 2007 they will have to take the new exam
- The current exam was suppose to have reciprocity with other states
- 8 states currently have the 2-tier exam
- The licensure board wants to split the exam because too many individuals are not passing the exam

Dr. Tom Davis discussed:

- We have to appeal to the board and asked them to listen to our concerns
- Ohio has a 1-tier law
- Skeptical about the group that is selling the exam
- We have a responsibility to the citizens of the state to do things the correct way
- 25 to 28 states have a 1-tier exam
- Concern about waiting two years to take the clinical component of the exam

Susan Norris Huss stated that:

- It is not a done deal
- She will ask specific questions to the other members of the board and NBCC
- She has written down all of the concerns mentioned today
- The board has had a difficult time during the past year and a half
- She encourage questions and dialogues

Dr. Lynne Guillot Miller stated that:

- Concerns can be sent to her and Dr. Jason McGlothlin
- Dr. Lynne Guillot Miller and Dr. Jason McGlothlin will speak to the board for the group
- Testimonies can be provided to Dr. Lynne Guillot Miller
- Carolyn Towner, our lobbyist, will provide guidelines regarding how to write the testimony

- Dr. Lynne Guillot Miller will provide information regarding the hearings to the listserv
