McGlothlin - Meeting called to Order – 7:17am

- Overview of agenda
- Introduction of officers (McGlothlin, Guillot Miller, Levitt, and Rainey)
- Announcement that volunteers will be needed to fill roles of past president
- Offered minutes of winter meeting
  - Underfer – move to accept
  - Leinbaugh – second
  - Voice approval

Levitt - Presentation of treasurer's report

- Sears – move to approve
- Davis – second
- Voice approval

McGlothlin - Announcement of new website [acesonline.net/ohioaces](http://acesonline.net/ohioaces)

- D. Granello – put workshop on website
- Richie – does not approve advertisement of workshops on listserv.
- D. Granello – use link to member sponsored workshops
- Leinbaugh – send periodic reminders regarding conferences and workshops
- D. Granello – post something regarding listserv etiquette.

McGlothlin - Announcement that the winter meeting and the supervision summit has been moved from the Fawcett Center to the concourse Hotel and Conference Center at the Columbus airport.

- Winter meeting is February 11, 2005
- Supervision Summit is April 29, 2005
- Will keep closer connection to national organization and keep the same theme of CREATIVITY and CHANGE in COUNSELOR EDUCATION and SUPERVISION
  - Sears – moves to accept dates and location
  - Guillot Miller – second
  - Voice approval

McGlothlin - how to attract attendance? (1) basic levels of supervision; (2) more advanced levels – research based; (3) offer supervision CEUs for counselor educators

- D. Granello – voted at last meeting to offer general ethics track
- P. Granello – market ethics training to field supervisors. Schedule time to meet with field supervisors at the summit
- Underfeld – offered to coordinate field supervision session
- Tromski offered to help
- Sears – suggested attracting school counseling supervisors as well
- D. Granello – suggested moving away from Dr. student presenting to Dr. student.
- McGlothlin - will write summary of supervision summit ideas. Asked about the use of student monitors, general approval of idea for use at the OACES conference

#### Underfer – leadership advancement

- Announced the establishment of a scholarship in the name of her parents for work related to leadership
- She is requesting that members donate money to establish the fund
- A detailed announcement will be sent to the membership regarding the scholarship
- Scholarship money will be awarded at the AOCC each year
- Also requested fundraising ideas.

#### McGlothlin - OACES ad hoc sub-committee with ODE (Sears, Davis, Whitfield, Guillot Miller, etc.)

- TIAC – functions as an alternative to NCATE. It does not delineate school counselor educational requirements
- McGlothlin has talked with other states – they have had difficulty dealing with them related to school counseling, none have anything in legislation.
- OCA meeting gave unanimous support for use of CACREP standards
- Sears – NCATE beefed up standard, TIAC responded by reducing standards, NCATE recognized CACREP, asked if we wanted to support NCATE and put CACREP into the law?
- Tromski – where does OSCA stand?
- McGlothlin – they are aware of TIAC, but have not responded
- Whitfield – they have accepted NCATES acceptance of CACREP, ODE has accepted TIAC, this goes into effect in January 2006. The board turned, regarding licensure of school counselors without teaching experience, because CACREP standards were accepted. Keeping CACREP would strengthen our bond with the ODE.
- Green – John Carroll has recently undergone NCATE and CACREP visits, they looked at data differently
- Davis – TIAC only affects School counseling programs at the institutional level. There is concern about institutions that accept it. Sees it as a professional issue.
- D. Granello – we need to hear OSCA's position and support those who have worked so long to get us here.
- D. Granello moved "I move that OACES endorse the position that the CACREP school standards be the standards for school counselor preparation and licensure."
- Davis – second
- Richie – asked if this is the opportunity to insert counselor after Master's degree.
- Sears – points out that the part of the law that is related to teacher/non-teacher is a different part of the Ohio revised code. Administrative role has impact the same as law.
- Underfer – stated the need for involving Carolyn Center in the process so she is up to date and can advise us.
- Renylods – will this affect smaller universities.
- McGlothlin – NO!
- Whitfield – ASCA is important. OEA and OFT will ask ASCA?OSCA standards. OSCA may not support – we need the endorsement
- Osborn – requested that McGlothlin ask Goins (OSCA President) for formal support from OSCA.

- Underfer – sees this as an opportunity for Ohio to take a leadership position and may be helpful to other states.
- P. Granello – need to educate administrators, train the principals
- D. Granello – present at principals conferences. Asked what are actions to take?
- Sears – the same actions we took before. Two ways, through teacher education commission or to attach it to another law. The committee is taking this action.
- Davis – bring in Towner and have her connect with Whitfield so she is up to date.
- Hall – need commitment from each University to support.
- The question is called

- Sears – asked for a show of hands vote.
- McGlothlin – For – 34, Against – 0, Abstain – 0

Davis - ACES conference will be held at the Hilton at Easton. He requested support for conference organization

McGlothlin – announcement ACES research grant

McGlothlin - Passed out new OACES member directory

D. Granello - voiced concern regarding the research grants available for study of Ivey model. Stated that she did not think it appropriate for the professional honorarium to, in effect, endorse a certain theory or framework for counseling and seek research support for a particular theorist. She further stated that OSU would withdraw from CSI if this continues.

- Osborn – updates on the website have been reworded.

Whitfield - ODE is pondering new rules on renewal of 2 year provisional license for school counselors. They can renew if they don't get a job initially. If 2 years passes, they can renew by taking 3 college credit hours. Renewal of teacher license will automatically update the counselor license.

Sears - Asked for support of those who work on CACREP standards to bring the standards up to date by including school counselor competencies.

Osborn - Announces that Davis and Sanders are 2 of the 5 committee members for the revision of CACREP standards.
